INTERIM SUSPENSION ORDER  
(Gov. Code, § 11529)

This petition was heard before Administrative Law Judge Cheryl R. Tompkin, State of California, Office of Administrative Hearings, on October 14, 2015. Petitioner was represented by Carlyne Evans, Deputy Attorney General. Respondent was represented by George P. Eshoo, Attorney at Law.

The evidence and oral argument presented at the noticed hearing on the Petition for Interim Suspension Order have been considered by the undersigned Administrative Law Judge. It is found that the requirements set forth in Government Code section 11529, for issuance of an interim order of suspension, have been met and that good cause exists to immediately suspend the acupuncture license issued to respondent. Accordingly, IT IS HEREBY ORDERED that Acupuncture License No. AC 1541 issued to respondent Randall James Neustaedter is immediately SUSPENDED. During the period of suspension, respondent shall be and hereby is immediately restrained and prohibited from practicing or attempting to practice as an acupuncturist in California and from holding or possessing his acupuncturist's wall and wallet certificates. Respondent shall immediately surrender his wall and wallet certificates to petitioner pending a final decision on the accusation filed in this matter.
